#### MATTERS ARISING

Anna working with YEP on Wildlife Hospital article scheduled for May (ie end of treatment season). Other opportunities to be reviewed ongoing.

LOE is now signed and handed over to NZOG - with a photo taken

Anna to update the annual NZOG Performance plan framework to reflect the 2017 Letter of Expectations, including new emphasis on capturing local benefits

Anna advised that NZOG did not put in a submission re the Marine Protection Forum but rather linked with the YEPT - as the timming was not quite right

#### NZOG GUEST PRESENTATIONS - NZOG ACTIVITIES

Andrew introduced himself covering his petroleum engineering background and his years with Shell Oil . He also talked about likely time tables and the effect of modern technology on the industry . He compared the Clipper project with others around the world – North sea , Norway and Denmark.

Andrew updated the Panel on changes to the company including changes in management and sale of interests in Kupe and Tui production fields, and consequent placing of the South Taranaki Community Panel on hold.

Daniel then spoke,more about the geological aspect of Barque prospect, in the Clipper permit, and the upcoming Regional Economic Impact Assessment Report which looked to answer the question — what would a large discovery mean in terms of jobs and economic impact locally, regionally, nationally To this end NZOG has engaged MartinJenkins and Beca to produce the report, including seeking data inputs from large industry on what having a significant gas resource on their doorstep could mean for economic growth. The report is due by the end of March. He emphasised the focus on gas rather than oil as this was a world wide growing trend - cleaner, more stable, able to be converted,

now a globally traded commodity. He also talked about the 2 main development options – condensate recycling and pipet-shore. Group discussion around range of aspects of project including consideration of seismic risk (ie given recent Kaikoura earthquake), where support services might be located, project timing and touched on regulatory processes.

A summary flyer on Clipper was circulated, as was a Panel update on other permits and activities.

## COMMUNITY INVESTMENT UPDATE

Anna updated on progress with support to Southern Science Fair website.

The previously circulated Dog Island project was discussed along with a 2<sup>nd</sup> application for the support of the bi annual Science Fair which was felt to be considered next year

Overall the Dog Island project was favoured – as a good example of a PP partnership and satisfied the funding criteria. Anna requested copy of Trust's operational report
